In addition, the student must sign, in the presence of the institutional official, the Statement of Education Purpose below. *If the student cannot appear in person to sign this Statement of Educational Purpose, the student will need to provide a copy of a government issued ID and this Statement of Educational Purpose notarized by a public notary.*
